Academic Life Coach (ALC):


**RESCHEDULING.** Rescheduling/cancellation of an appointment must be made 24 hours in advance. Both parties will make every effort to do so. If you (the Student) cannot make a scheduled session and cannot provide 24 hours' notice to the ALC, please let the ALC know as soon as possible, and provide an explanation for the cancellation. The ALC may or may not have availability to reschedule the appointment immediately, and it will be your (the Student's) responsibility to make up any missed sessions.

**RECORDING.** I, \_\_\_\_\_\_ (the Student), understand that my academic life coaching sessions with the ALC may be recorded for training purposes. Only the coach(es) and instructors for the Academic Life Coaching program will listen to the recordings and the content of the recordings will remain confidential. I understand that *Student Success & Retention* ALC's are FERPA trained.

**LIMIT OF LIABILITY.** YOU EXPRESSLY UNDERSTAND AND AGREE THAT <u>Texas Tech University</u> <u>Systems, The Office of the Provost, or Student Success & Retention</u> SHALL NOT BE LIABLE TO YOU (THE STUDENT) FOR:

- (C) ACADEMIC LIFE COACHING SESSIONS ARE VOLUNTARY, COOPERATIVE, AND STUDENT-DRIVEN. PARTICIPATION DOES NOT GAURANTEE SUCCESS, AND STUDENT SUCCESS AND RETENTION MAKES NO PROMISE OF RESULTS. RESULTS ARE ENTIRELY CONTINGENT ON STUDENT ACTIONS, BEHAVIORS, AND PARTICIPATION.
- (D) IN THE EVENT THAT THE STUDENT DIVULGES INFORMATION THAT THE ALC DETERMINES THAT THE STUDENT IS A RISK TO HIM/HERSELF OR OTHERS, THE ALC IS LEGALLY RESPONSIBLE TO NOTIFY DEPARTMENT SUPERVISORY PERSONNEL, THE UNIVERSITY TITLE IX COORDINATOR OR DEPUTY COORDINATOR, UNIVERSITY COUNSELLING AND/OR OTHER APPROPRIATE UNIVERSITY PERSONNEL.


